- 7. That the school will not open classes under CBSE pattern particularly class IX/X/XI/ XII and will not use CBSE name in any manner without obtaining affiliation.
- 8. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye laws, directions issued from time to time and the law of the land.
